Privacy Policy

1. Scope and responsibility:

2. Purposes of the processing and legal basis

3. How we use your data

We may use your information to:

- 2. Inform you about relevant opportunities and activities (including project news, results, collaboration opportunities and event invitations);
- 3. For research activities upon receiving a signed informed consent from you.

Your information will be used for purposes directly related to the website and/or project activities and will never be shared with third parties (such as marketing companies).

4. International transfers of personal data

There will be no exchange of personal data between EU and non-EU countries within the project *Code: Refarm*.

5. Retention Period

The *Code: Re-Farm* project will keep the personal data of the users for the period necessary for the accomplishment of the purposes for which they were collected. The project *Code: Re-Farm* will maintain this data through the period that it is obliged to by the law however no identifiable data will be available as the data will be anonymized.
